ABOUT US

Hindustan Petroleum Corporation Limited (HPCL) is a Maharatna Central Public Sector Enterprise (CPSE) and a S&P Global Platts Top 250 Global Energy Company with a ranking of 54. HPCL has a strong presence in downstream hydrocarbon sector of the country with over 18% share in petroleum product marketing and also has business footprints across other energy verticals & various overseas geographies. During 2019 - 20, HPCL recorded Profit after Tax (PAT) of Rs. 2,637 Crore.

HPCL owns and operates refineries at Mumbai & Visakhapatnam with designed capacities of 7.5 Million Metric Tonnes Per Annum (MMTPA) & 8.3 MMTPA respectively. HPCL also owns the largest Lube Refinery in the country at Mumbai for producing Lube Oil Base Stock with a capacity of 428 TMTPA. HPCL holds 48.99% equity stake in JV company, HPCL-Mittal Energy Limited (HMEL) which operates a 11.3 MMTPA capacity refinery at Bathinda (Punjab) and also has 16.96% equity stake in Mangalore Refinery and Petrochemicals Limited (MRPL) which operates a 15 MMTPA capacity refinery at Mangalore (Karnataka).HPCL has the second largest petroleum product pipeline network in India with network length of 3,775 km and supplies petroleum products across the country through a vast marketing network consisting of 70 depots, 41 terminals, 50 LPG bottling plants, 44 aviation fuel stations, 6 lube blending plants, over 17,800 retail outlets, 245 lube distributorships and over 6,151 LPG distributorships.

HPCL intends to set up Second Generation Ethanol Biorefineries in 4 states of India viz. Punjab, Bihar, Uttar Pradesh and Andhra Pradesh. The Bhatinda Biorefinery project is proposed to be completed by February 2023 and the project execution is in progress. Biomass requirement for Bathinda Biorefinery is approximately 730 tons/day (approx. 219 Kton/annum considering 300 days of operation). The supply chain of biomass will require harvesting collection, storage and transportation of biomass within a range of 25-50 km radius of Biorefinery. At this advance stage of the project, HPCL intends to engage a Biomass Advisor on Fixed-term contract for 3 years to monitor and develop a robust sustainable supply chain of biomass in Bathinda, Punjab.

2. ELIGIBILITY CRITERIA:

3. ROLES & RESPONSIBILITIES

The expected key roles and responsibilities of the biomass advisor have been enumerated below:

- a. To study agricultural cropping pattern of a selected location for freezing cropping zones.
- b. Identify crop wise area, production data collection for different agro-climatic zones for freezing cropping pattern and trend.
- c. Work out the cost of cultivation of different crops and its Life cycle analysis for evaluating Agri economical pattern and GHG factors.
- d. On field survey of biomass production for quantifying the biomass availability for the projects.
- e. On-site study of advance mechanization in Crop cultivation for the advancement in post-harvesting systems for biomass collection.
- f. Calculate Biomass surplus for bioethanol projects for exploring business opportunities for selected locations in India.
- g. Study the existing biomass supply chain module for creating Rural entrepreneurs model for sustainability.
- h. To establish an economically viable and sustainable biomass supply chain.
- i. To monitor the biomass supply chain and crucial aspects such as quality, quantity, value (Socio economical) and delivery schedule.
- j. To create value addition in the farming community by making clusters and monitoring fund transfer for the supply of biomass.
- k. To establish the viability of alternative feed stocks like sweet sorghum, pearl millet, Napier grass etc. for contract farming on barren land.

- 1. Develop and implement profit improvement plans.
- m. Communicate values, business goals and represent the organization to internal and external stakeholders.
- n. Manage vendor relationships (e.g., third-party logistics)
- o. Oversee organization-wide management of the strategic sourcing, procurement, contracting and evaluation of services.
- p. Manage/coordinate operations planning process.

Please note that the above list is indicative and not exhaustive.

Below are the major deliverables expected from the Biomass Advisor:

- a. Interacting with the farmers on regular basis to sensitize them to supply the biomass and to provide their barren land for storing the biomass.
- b. Conducting nukkad meetings with the villagers and Panchayats to sensitize them. There are more than 290 villages and 300 Panchayats in the Bathinda district.
- c. Conducting frequent meetings at village and district level with the Village Level Entrepreneurs (VLE) to associate with the supplier.
- d. To interact with the Krishi Vigyan Kendra (KVKs) in order to facilitate support to farmers.
- e. To monitor the suppliers on procurement / hire / lease of machinery like balers, rakers, trolleys etc.
- f. Though the processing, storage and supply of the biomass to HPCL premises will be responsibility of the supplier, the biomass head will coordinate with the suppliers and other stakeholders to ensure that a smooth supply chain is established in order to receive uninterrupted daily supply of required quantity of biomass after commissioning of the Bio refinery.
- g. To inspect the storage depots and ensuring the safe storage of the biomass and quality of the biomass.

4. EMOLUMENTS

A consolidated lump sum monthly remuneration will be paid which is negotiable commensurate with experience and qualification. In addition, conveyance cost and mobile call charges will be paid. It is to be noted that the emoluments are subject to deduction of statutory professional tax and other taxes and statutory deductions as applicable.

5. PERIOD OF CONTRACT

Initially for a period of 3 years which may be extended by further 1 year subject to the requirement and satisfactory performance.

6. SHORTLISTING CRITERIA

Shortlisting of the candidates will be done as per the eligibility criteria. Candidates fulfilling all the eligibility criteria (based on the online application submitted), will be considered for further selection process. In the event of number of applications being large, the Company will adopt a shortlisting criteria to restrict the number of candidates to be called for the interview. The shortlisting criteria will be based on any or all of the criteria i.e. higher relevant experience, higher qualification etc.

Final selection shall be done basis the personal interview. Depending on number of candidates fulfilling all criteria, candidates will undergo single stage or multiple stage interview.
